A drug and alcohol policy can be one of those documents which sit around until there is an issue, and in some cases, amendments are required for it to be fit for purpose. LABORATORY SERVICES

A critical part of the drug testing process is laboratory confirmation. Having an analysis conducted on the sample of eccrine sweat, oral fluid, urine or hair shows exactly which metabolites are present and gives a legal standing to progress through the steps detailed in your policy.

As well as confirming a 'non-negative' screening result, the lab process confirms that any disclosure of medicines by the donor that cause a cross-reacting 'non-negative' are legitimate and not a decoy for a more serious substance. Peace of mind for you as an employer and for your employee. Our laboratory confirmation process is UKAS approved for all matrices.



Drug Screening Products

Drug testing is the established way to quickly detect evidence of illicit or illegal drugs in a donor's sample. As drugs pass through the body they can be found in different matrices at different times.

Each drug test parameter looks for tiny particles of biological evidence of drug use. These particles are called metabolites which are unique in their shape and form, so highly distinguishable from each other. That's why all our tests are so accurate.

Drug Screening Sample Collection and Testing Service

Collection to Results Drug Testing Service

Many of our customers conduct rapid drug screening on-site, but for instances where that is not viable, our collection and screening service is the next best thing.

With national availability, our team are experts in efficiency - collecting the sample with minimum fuss and minimising the individual's time away from work.

As well as collection, we can conduct rapid screening at the same time - giving you answers there and then.

Rapid screening is the best way to eliminate negative samples, but when you do have a positive (non-negative), you need to ascertain exactly what is causing the result. In this situation, we send the sample back to the laboratory to undertake confirmation testing.

Our UKAS accredited laboratory analysis is capable of measuring parts per billion or even parts per trillion using the latest GCMS techniques, equivalent to the concentration of a drop in a domestic swimming pool, so we can find the typically tiny levels of drug metabolite.





Collection & Testing Services

For-Cause Collection Service

- A trained Collection Technician will arrive at your site within 2 hours from request.
- This service is available 24 hours a day, 365 days a year using our callout number.
- A Collection Technician will visit your site for a period of up to 4 hours. This is approximately enough time for the collection of up to 10 donor samples.

Sample Analysis per donor

This includes:

- Sample collection
- Drug screening which detects the 10 most commonly abused drugs including: Amphetamines, Methamphetamines, Barbiturates, Benzodiazepines, Buprenorphine, Cannabis, Cocaine, Ketamine, Methadone and Opiates. This primary screen will indicate negative and non-negative samples.
- Documentation to list any medication (where appropriate) and consent to test.
- LCMS confirmation of any non-negative screens. This LCMS method will produce legally defensible results. A 'fast track' service is available as an option.
- Result interpretation from a toxicology specialist if required.
- An alcohol test (where required using an approved breath test monitor, including a second confirmatory test if required. This will produce legally defensible results.
- The Collection Technician's travel expenses and waiting time are included in an all inclusive package.

All processes in accordance with UK and European Workplace Drug Testing Guidelines & Chain of Custody procedures.



Oral Fluid Screening

The biological content of oral fluid is directly relational to blood plasma.

Therefore, if we detect drug metabolites in oral fluid, those metabolites are still present in the blood stream, indicating that the substance has recently been active in the body. This makes oral fluid is the choice matrix for ‘for-cause’ testing, but can also be used for random and pre-employment situations where you need to check someone is safe to enter site or hazardous environment.

Screening using our sophisticated range of oral fluid tests is less invasive than urine screening, and doesn’t require the same preparation.

Urine Screening

Drug metabolites begin appearing in urine a couple of hours after a substance is taken. These metabolites can be detectable in a urine sample for several days and up to 30 days after use.

Whether using a dip or cup screening test, urine presents the widest range of parameters for drug screening, and is often the first matrix to feature new parameters.

With best practice procedures in place, urine screening is a swift and reliable method of screening for recent and habitual drugs of abuse activity.

Alcohol Screening

Take Alcohol Readings

In our experience, alcohol use or the effects of alcohol in the workplace are far more common than drugs of abuse; so monitoring using random screening, or identifying if it was a causal factor after an incident, using a 'for-cause' approach to screening, has great benefit.

Modern fuel-cell sensor breathalysers allow us to screen for alcohol using the same technology and accuracy as roadside testing, detecting from 0.001 BrAC to the legal driving limit and beyond.

As well as instruments, we offer a range of single-use quantitative and semi-quantitative alcohol screens for breath and saliva.

Laboratory Confirmation Kits

Rapid Screening allows you to eliminate the negative samples quickly and efficiently. If you do find a non-negative result, the next stage is to find out exactly what is in the sample and the quantity. We do this by sending the sample to the laboratory where it is analysed using advanced chromatography methods such as GCMS and LCMS.
